good health and has not been ill with any communicable condition in the last 14 days. I further certify that my
dog has not harmed or shown any aggressive or threatening behavior towards any person or any other dog.

I have read and understand the following;

1. I understand that I am solely responsible for any harm caused by my dog while my dog is at BlackJacks Dog Daycare. I hereby release BlackJacks Dog Daycare of any liability arising from my dog's attendance in daycare.
2. I further understand and agree that admitting my dog to daycare at BlackJacks Dog Daycare that the Staff at BlackJacks Dog Daycare have relied on my representation that my dog is in good health and has not harmed or shown any aggressive or threatening behavior towards any person or any other dog.
3. I further understand and agree that BlackJacks Dog Daycare and their Staff will not be liable for any problems that develop, provided reasonable care and precautions are followed, and I hereby release them of liability of any kind whatsoever arising from my dog's attendance at, and participation in, daycare.

4. I further understand and agree that dogs can sometimes receive minor cuts and scratches at daycare and any possible minor injuries that develop with my dog will be treated as deemed best by Staff and BlackJacks Dog Daycare at their sole discretion, and I assume full financial responsibility for any and all expenses involved.

5. I further understand and agree that, in the event of an emergency, BlackJacks Dog Daycare Staff will first attempt to contact me, seconded by an attempt to contact the emergency contact on record. BlackJacks Dog Daycare may also contact the veterinarian on record directly, or an emergency veterinarian, if it is determined that immediate treatment is necessary. BlackJacks Dog Daycare Staff maintain sole discretion, without liability, in emergency matters. I agree to pay for all medical treatments received, including transportation to an emergency veterinary facility, promptly upon picking up my pet.

6. I further understand that all charges are to be paid in advance, or upon pick up on the day of scheduled visit. Daycare hours are 7:00 am to 6:00 pm. A late charge will be applied after 6 pm, and I agree to pay this charge when picking up my dog.

I certify that I have read and understand the Liability policies of BlackJacks Dog Daycare set forth on the preceded pages and that I have read and understand the conditions and statements of this agreement.
